INSTRUCTIONS

- File in person or by mail: A completed application, along with the following:
- a copy of the valid driver's license of the applicant
- a copy of the valid registration for the car of the applicant
- a check payable to the Village of Pelham for twenty five dollars (\$25)
- a copy of the applicant's current New York State Motor Vehicle Form 664.1 WITH ITS MEDICAL CERTIFICATION COMPLETED AND SIGNED BY AN AUTHORIZED MEDICAL PROFESSIONAL
- a copy of the driver's valid, current, handicapped parking permit issued pursuant to § 1203-a of the Vehicle and Traffic Law of New York State or a copy of the registration of the passenger car issued pursuant to § 404-a of the Vehicle and Traffic Law of New York State
- A Doctor's letter that is dated within the month of the submission of the application and that indicates how many feet the applicant can walk;
- a written explanation of why the applicant neither has nor can create adequate, accessible parking at the location where he or she must park overnight and why the issuance of a HOPE permit is necessary because of his or her disability.
- a self-addressed stamped envelope and a check payable to the Village of Pelham should be included with the package submitted to the Village Clerk's Office at the above address.

In Person: A completed application, along with presentation of all items listed above, and payment of the \$25 fee, should be brought to the Village Clerk's Office. Permits are issued between the hours of 8:30 AM and 4:30 PM Mondays through Fridays.

NOTE: THE HOPE PERMIT ALLOWS AN EXEMPTION TO THE OVERNIGHT PARKING PROHIBITION BETWEEN 2 - 6 A.M.
